Eligibility: Exhibit open to any Florida artist, male or female, over the age of 18. (up to 2 entries of work) in :

Paintings, Photography, Jewelry, Sculpture in clay, stone, metal, glass, wood, fibers, paper, Mixed Media

1. **NUDES are acceptable but No Violence.** The Armory Art Center reserves the right to reject inappropriate works.
2. Work cannot have been previously shown at the **Armory Art Center**.
3. There is 36" WIDE framed size limit. If concerned about eligible work, please call **Ann Schwartz 561-737-4248**

WITVA Exhibit "Artistic Visions II" is open at the Armory Art Center Gallery, Monday-Friday 10am-4pm, Saturday, 10 am-2pm, Closed Sunday. (1700 Parker Ave.)

Preparation of Pieces:

1. Paper media must have undamaged frames and mats; no debris between glazing material and art.
2. Unframed oils/acrylics must be framed or finished on all sides with no staples showing.
3. All 2-D must be securely wired (please tape ends of wires) No sawtooth hangers, no spring clips or string.
4. Sculptors will be provided pedestals by the Armory Art Center. If using theirs, 48"high and 60lb maximum.
5. Self-standing sculptures-60" high, 100 lb maximum. Call Ann if concerned at 561-737-4248.
6. All entries must be labeled on back, and all items **must** be for sale. If sold they must remain for the entire exhibit.
7. **Please note: 40 % commission on all sales (10% to WITVA scholarship fund AND 30% to the Armory Art Center)**
7. Locked cases available for jewelers and small sculptures.
8. **This is a juried show. Cash Awards will be given at Reception on March 30, 2012.**
9. **Directions: I-95, exit east on Belvedere Road to Parker Ave. and turn left. Go north to Park Place, then turn right. Parking lot is on the left. Additional parking is behind the Firehouse.**
10. Insurance coverage on the Armory premises is provided at the artist's net price from the time of delivery to time of pickup. The cost of shipping and insuring artwork in route is the responsibility of the artist.
